We process and use your personal data in accordance with the provisions of Czech legislation (Personal Data Protection Act No. 101/2000 Coll.) And European legislation (Regulation (EU) 2016/679 of the European Parliament and of the Council).

What personal data do we process and why

We keep the largest part of the personal data that we process about our customers and other business parties in connection with the offer and provision of our services. In the vast majority of cases, these are basic contact details such as name, surname, telephone and email. Without this information, we cannot communicate with you and thus ensure the performance of our services, which results from a properly concluded contract. Legal regulations and legislation of the Czech Republic also oblige us to process your personal data in certain cases. This is typically the storage of data according to legal requirements due to bookkeeping. If you are a job seeker, we will process the personal data you send us for our needs when recruiting employees, so that we can possibly sign an employment contract with you. If you are not a successful candidate, your personal data is removed from our records. All the above-mentioned personal data, which arise from the initiative of our mutual communication and interaction, are managed by the internal system of personal data protection according to the valid legislation. Therefore, we control access to personal data, technical measures for their security and the period of their existence to the maximum extent.

The amount of time we process your personal information

We process and store personal data of customers and third parties for the time strictly necessary to ensure all rights and obligations arising from the contract, and for the period for which we are obliged to retain data in accordance with generally binding legal regulations.

Your rights

It is your natural right to receive information about your data that we process about you. You also have the right to correct or block incorrect or outdated data, the right to restrict processing and the right to object to the processing. In certain cases, you have the right to delete. In addition, we are obliged to transfer your personal data to the personal data controller / processor of your choice at your request. If you want to ask anything about our processing of your personal data, contact us at obchod@metalcasting.cz If you are convinced that we do not handle your data adequately and in accordance with legal standards, you have the opportunity to file a complaint with the supervisory authority, which is the Office for Personal Data Protection.

Transfer of personal data

We use all personal data obtained from customers and third parties exclusively for the internal needs of the company, we protect against misuse and we do not provide them to third parties without prior notice or consent. Exceptions are external companies that provide support services and state authorities for us. We may or must provide your personal information to these entities to a minimum extent, for example by: - investigating the illegal use of our services or for legal purposes, the data may be passed to criminal investigation authorities - managing our information systems and applications. All of these service providers are contractually required (outside public authorities) to process your personal data in accordance with the terms of personal data protection and applicable legislation.
